With long term interest in the Israeli innovation arena we can now take our activities and presence in the local market to the next level, by launching CRADLE Tel Aviv."

- <u>Allegro.ai</u> is a deep learning computer vision platform, which provides a complete product lifecycle management solution for Al development & production, starting with computer vision.
- <u>Percepto</u> A leading provider of autonomous on-site multi-mission drone systems for enterprises. Percepto's real time computer vision technology enables businesses to operate drones directly from the management system without any human piloting.
- OPSYS Tech Ltd A fast growing private company providing solutions for a wide range of applications utilizing fiber optics technologies.
- D-ID An Al solution that protects identities from face recognition. D-ID's groundbreaking technology produces photos and videos which are unrecognizable to face recognition algorithms, while keeping them similar to the human eye.

Hyundai signed an MOU with the Technion – Israel Institute of Technology, one of the world's top science and technology research universities, and the Korea Advanced Institute of Science and Technology (KAIST) in September 2017, to conduct joint R&D projects around AI.

Hyundai Motor plans to open additional CRADLE offices in Berlin and Beijing as the company aims to move beyond providing just means of transportation. CRADLE is reinforcing collaborations in order to speed up the development of cutting-edge technologies crucial to commercializing autonomous vehicles, which will provide customers freedom in both space and time.
